### IMPORTANT DETAILS

**Date:** Saturday, November 17, 2018

**Horse:** Horses are not provided. Riders must bring their own.

**Registration:** 8am **Ride:** 9am–Noon (includes lunch after the ride)

**Registration Fee:** \$35 per rider 16 and up. \$25 per rider under 16. Registrations received after the 14<sup>th</sup> will pay a \$5 late fee. Registration includes lunch after the ride and a commemorative t-shirt.

**Commemorative T-Shirt:** FREE – must order by Nov 9<sup>th</sup>

**Friday Night Social – S'mores & Legends** – Friday, Nov. 16<sup>th</sup> from 4 – 9pm – **Cost FREE**

**Location:** Hardee Lakes Park. From Hwy 17 travel West on Hwy 62 for 7.5 miles. Turn Right onto St Road 663. Turn left on Ollie Roberts Rd and travel 1.3 miles. The park will be on your right.

**Camping:** Hardee Lakes Park offers both primitive and hook-up camping. Camping fees are not covered in the trail ride registration fee. Riders interested in camping are responsible for making those arrangements. Please call (863) 781-1053 to make a reservation. (additional camping details and park information are included in this packet)

**Park Fees:** General park entry fees are waived for riders.

### RULES AND REGULATIONS

1. To participate, all riders 16 and older must pay a registration fee of \$35. Riders 15 and under pay \$25. Registrations received after the 14<sup>th</sup> will pay a \$5 late fee.
2. Florida State Law requires a current original **Negative Coggins Paper** or certified copy must be available. **They will be checked upon entry to the park.**
3. No alcoholic beverages will be permitted on the premises.
4. NO DOGS OR PETS OF ANY KIND.
5. NO STALLIONS-NO EXCEPTIONS!
6. Kicking horses must have a red ribbon on their tails. Red ribbons will be available at registration.
7. No riding double, bareback riding or ponying horses during the ride.
8. Littering will not be tolerated (including cigarette butts and hay string).
